The Department of Empowerment of Persons with Disabilities, Ministry of Social Justice has recommended the Rights of Persons with Disabilities (RPwD) Act, 2016. The college is committed to make continuous efforts to follow the recommendation of RPwD Act, 2016 (enacted on 28.12.2016) at possible level.

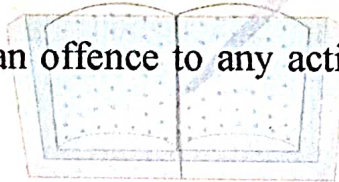
